Please add 7% MA/Local Tax and 22% House Charge.

Purchase of paper products as well as rental of china, glass, silver and linens are extra. Requests for rentals must be made 2 weeks prior to the function.

Payments: A 30% deposit is required to hold your function date. The deposit will be credited towards your final bill. The balance is due 7 days prior to function. A confirmed menu and guaranteed count is required 7 days prior to your function. Actual billing is based on the guaranteed count or actual number served, whichever is greater.

We accept American Express, Visa and MasterCard. A credit card is needed on file for any incidental charges.

Cancellations made two weeks or less in advance of your function will forfeit the deposit. If you wish to reschedule at the time of cancellation, the deposit may be applied towards a future event.

Additional labor charges will be determined by party size & event and location. Venue rental and kitchen fees are the client's responsibility.
